## **Continuation of Agreement Terms:**

- 5. After my appointment becomes effective, I may not purchase, or commit myself to purchase, more than €500 of goods on my first order or services from the Company, or other independent Forever Business Owners, nor will I be required to do so.
- 6. I agree that the Company may:-

- 8. I am a wholly independent Forever Business Owner and not an agent, employee or legal representative of the Company. As such, I will be responsible for my own expenses, including all taxes (including Value Added Tax), PRSI contributions and fees or licences which are payable or required to conduct my business. I am not authorised to make representations or incur any liabilities on the Company's behalf and agree not to purport to do so. As an independent business person I am entitled to arrange for such assistance in the conduct of my business as I consider appropriate, to be provided to me by such persons as I choose, and to delegate the performance of my obligations to those persons.
